

Extending accessibility



Adobe Form Server technology enables a unique form transformation known as accessible HTML (aHTML). The electronic form layout is changed by aHTML from its typical left-to-right, top-to-bottom configuration (screen shot on left) to a vertical column—making it easier for users to navigate and complete forms.

Comply with Emerging Legislation

Countries around the world are developing and instituting legislation requiring Web-based information to be more accessible to their citizens.

In the **United States**, the federal government recently enacted section 508 of the Rehabilitation Act requiring federal agencies that acquire, develop, or maintain electronic and information technology to ensure accessibility for citizens and government employees with disabilities.

European Union member states are adopting action plans to ensure equal participation for all in today's knowledge-based economy. They have targets set for specific accessibility objectives and for review of legislation and standards to ensure conformity with accessibility principles.

Canada has published, as part of its Government Online initiative, guidelines for Internet accessibility.

Australia has policies for the accessibility of electronic commerce and new service and information technologies.

For disabled employees, equal access to information and core business processes are key factors in maximizing their opportunities and potential. Providing all employees with the right tools to perform their daily tasks will increase satisfaction and performance levels—which translates into greater efficiency and lower operating costs, directly affecting your bottom line.
